1. APPLICATION FEE:

New students must complete the required application forms. A *non-refundable fee of \$50.00* must accompany the new student's application. New students are admitted according to the general admissions requirements and availability policy. The application fee is a one-time fee.

2. ENROLLMENT DEPOSIT:

A *non-refundable enrollment deposit of \$400.00 per child* is due by February 19, 2010. This amount will be credited to the child's tuition account. Upon acceptance of the student's application, receipt of the enrollment deposit, and a signed enrollment agreement, the student will be officially enrolled for the 2010-2011 school year.

3. FAMILY MEMBERSHIP FEE:

A charge of \$200.00 per family is required of those families not owning Monroe Educational Foundation stock or a Family Membership Certificate. You may contact the school office if interested in purchasing MEF stock or a Family Membership Certificate.

4. YEARBOOK (Silver Spur):

Each family is charged \$50.00 for a yearbook. If you want additional yearbooks, please indicate the number of additional yearbooks you want at \$50 per yearbook on your Enrollment Agreement.

PAYMENT PLANS:

| A. Early Payment Plan: | All tuition must be paid by May 1, 2010. The Early Payment Plan earns a 2.5% discount on the tuition. |
| B. Semester Plan: | One-half of balance due must be paid by June 1, 2010. The second half of balance due must be paid by November 1, 2010. If the second half of balance due is not paid by December 1, 2010, the student will be placed on a monthly payment plan for the balance of the school year. |
| C. Monthly Plan: | Please call the school office to arrange a monthly payment plan. A charge of \$10.00 is added per child per month to the monthly payment plan. |

Multiple Child Discounts

Multiple child discounts apply only to tuition.

- 15% of tuition for the 2nd youngest child.
- 30% of tuition for the 3rd youngest child.
- 60% of tuition for the 4th youngest child.
